Invitation for Bids for the Construction of Health Post Building (Type-4 Health Post Building at Chhapa, Kaligandaki RM, Syangja)

1. The Government of Nepal and Kaligandaki Rural Municipality, Syangja has allocated funds towards the cost of Construction of Health Post Building (Type-4 Health Post Building at Chhapa, Kaligandaki RM, Syangja) and intends to apply part of the funds to cover eligible payments under the Contract for KLGD/W/NCB/CHP/03/077/78. Bidding is open to all eligible as per Section V of bidding document.
2. Kaligandaki Rural Municipality, Office of the rural Municipal Executive invites electronic bids from eligible bidders for the Construction of Health Post Building (Type-4 Health Post Building at Chhapa, Kaligandaki RM, Syangja) under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 2,05,00,000
Minimum Work experience of similar size and nature: Nrs 1,35,00,000
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the website of Kaligandaki Rural Municipality www.kaligandakimunsyangja.gov.np or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document Rs 5,000.00 Rajaswa (revenue) account as specified below.

6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Hrs on 13th January 2021. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 13th January 2021 at the office of Rural Municipal Executive, Kaligandaki Rural Municipality, Syangja.
8. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs 480,000.00, which shall be valid for 30 days beyond the validity period of the bid. Bidder who choose to provide bid security in form of cash, the cash amount should be deposited in dharaui account of Kaligandaki Rural Municipality, Account No. 06700202CA at Prime Bank Ltd., Kaligandaki Branch.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever
