6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 07-05-2026 13:00 at the office of kaligandaki rural municipality kaligandakiruralmunicipality-04, Birgha Syangja Gandaki Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 17000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]).
